

Antakshari Foundation was registered as a charitable trust under the Indian Trusts Act 1882 in December 1996 by a few inspired and committed youth who were engaged in rural development for a long time. The organization tries to develop a new change process out of the learning of earlier ones - a process that carries on from one individual to another.

The organization works collectively by building a network with the government, community, individuals, and civil society. The organization endeavors to contribute to promoting a secular, non-discriminatory, non-frightening, transparent, and non-hierarchical environment both within and outside the organization. The focus is to work primarily with socially deprived and marginalized groups, and poor communities with a special focus on children who are vulnerable and living in difficult circumstances.

The team at AF consists of a dedicated team of grassroots leaders who are self-motivated, inspired, and facilitated as a group of development professionals. The organization believes that the team should be seen as a potential resource, someone who possesses sound knowledge & skills. This would enable a better and safer protective environment to children who are in diverse circumstances. Currently, the organization is actively working in two states i.e. Delhi and Rajasthan. In Delhi, the organization runs a "Skill Development" program for marginalized children. In Rajasthan, organization provides field based intervention in the districts of Jaipur, Ajmer, Bundi and Kota. Along with field based intervention, the organization also takes up research and documentation in the area of Child Protection. In addition to this, the organization with Freedom Fund is implementing a project titled "Child Labour Free Jaipur" and also running "Railway Childline (1098)" at Jaipur Railway Junction under the Integrated Child Protection Scheme. Expanding its horizon, the organization has become a technical support agency for:-

- Department for Child Rights (DCR), Rajasthan for the effective implementation of ICPS, POCSO Act, 2012 and JJ Act, 2015.
- Centre for Child Protection of the Sardar Patel University of Police, Security and Criminal Justice, Jodhpur for promoting child rights through academia.
- The Child Resource Centre of HCM RIPA is for the effective functioning and capacity building of various stakeholders working in the Juvenile Justice System.

The organization provides assistance to various departments /agencies, statutory authorities, child protection practitioners, lawyers, and other concerned stakeholders in realizing Child Rights. It is also engaged in developing IEC material, guidelines, and a journal.

### **Overview of the Report**

The Antakshari Foundation works according to the needs of the community, and there are emerging issues related to child protection in the country and the states. It also understands the need for greater accountability from non-governmental organizations (NGOs). In the report Antakshari Foundation has tried to maintain complete transparency for all its existing and potential stakeholders. The report contains details of external influences at the grassroots level and provides support to the state government to hold hands in intervening at the policy level on child protection issues at the state level.

Over the years, the interventions by Antakshari Foundation have grown into five major verticals for integrated development of the community:

- Child Right & Child Protection
- Education (Bridge Schools, Digital Night Schools, Teaching, Learning Material, Enhancing skills of children through vocational training, Cadre Development through degree & diploma courses, E - Library, Bal Sansad)
- ➢ Women's Right
- Skill Development
- ➤ Health

### **Our Reach**

The Antakshari Foundation, which has a rich history of working across multiple districts in Rajasthan, has recently focused its efforts in the districts of Ajmer, Jodhpur, Barmer, and the newly created districts of Beawar and Balotra. One of its key initiatives in these regions is the 'Pragati' project, which is aimed at supporting the educational aspirations of young , particularly those who have dropped out of school. The foundation is collaborating with Educate Girls, a well-regarded non-governmental organization, to address the challenge of girl child education in these areas. Through the Pragati project, the foundation aims to enroll and reintegrate out-of-school girls into the education system by providing them with the opportunity to complete their 10th grade through the Rajasthan State Open School (RSOS) system. This initiative is crucial in breaking down barriers to education such as socioeconomic challenges, gender bias, and geographic isolation, which often hinder girls from continuing their education. By offering a flexible learning platform through RSOS, Pragati ensures that girls, who may have otherwise missed out on formal education, can catch up and complete their schooling. In addition to academic support, the project also emphasizes awareness-building and advocacy around the importance of girls' education, thus empowering communities to value and support the education of young girls. This collaborative effort in Ajmer, Jodhpur, Barmer, Beawar, and Balotra not only strengthens educational access but also fosters a culture of inclusion and gender equality, giving these girls a brighter, more sustainable future.


### **Organizational Approach**

### **RAILWAY CHILD LINE 1098 JAIPUR**

Railway Child Line 1098 is a dedicated helpline service that provides immediate support and protection to children in distress at railway stations across India. Operated by various child welfare organizations in collaboration with the Indian Railway authorities, this service aims to safeguard children who are stranded, abandoned, trafficked, or separated from their families while traveling. The 1098 helpline is accessible to anyone who notices a vulnerable child in need of help, ensuring a rapid response through a network of trained professionals, child protection officers, and volunteers. The service offers a range of support, including rescue operations, temporary shelter, medical care, counseling, and efforts to trace and reunite children with their families. By working with law enforcement agencies, child welfare bodies, and other stakeholders, Railway Child Line 1098 plays a crucial role in providing a safety net for children and ensuring their well-being during transit.

CHILDLINE is India's first 24-hour, free, emergency phone service for children in need of aid and assistance. Whether you are a concerned adult or a child, you can dial 1098, the toll free number to access our services. We not only respond to the emergency needs of children, but also link them to services for their long-term care and rehabilitation.

CHILDLINE India Foundation works excessively towards the reformation and help of marginalized children. These children are frequently denied basic education and are forced to involve themselves in odd jobs so that they can earn some money for their livelihood. CHILDLINE from its inception has always aimed at providing assistance to the needs of these marginalized children and link them to long term services which will help them to lead a better life.

Antakshari Foundation has started Railway Childline 1098 at Jaipur Railway Junction under the Integrated Child Protection Scheme of Government of India.It has been universally recognized that every child is a rights holder and, as a unique and valuable human being, has rights to be safe and be protected from all forms of abuse, violence, neglect and exploitation and to be safeguarded from falling into vulnerable situations.



Children living on the railway stations and other transport terminals constitute a highly vulnerable and marginalized section of the society who normally enters the Railway platforms to eke out a living or for the security it offers. They are often seen trudging on railway tracks picking scrap, standing with outstretched palms at traffic signals, selling water bottles, plastic toys and gutkha packets, lying sprawled under railway staircases, rummaging through garbage cans to salvage a lunch, trying to escape a police eye and enduring blows. One brushes past them while scrambling to catch a train or at the most, give some alms or food out of pity.

The child in contact with the railways, as defined in Juvenile Justice Act (Care & Protection of children) Act, 2015 as requiring care and protection and also includes my child travelling, living, working or in conflict with law, on any part of the railway premises or in any train or railway vehicle. The purpose of running railway childline is to ensuring care and protection of children in contact with Railways as per the Standard Operating Procedure (SOP). Till so far, there has been 155 cases has been came in contact with railway childline of missing children, trafficking, child labour, abuse with children which has been produced to Child Welfare Committee (CWCs) for further proceedings as per Juvenile Justice (Care and Protection of Children) Act, 2015 and Model Rules 2016.

Antakshari Foundation rescued several children and provided a safe asylum for the CNCP children, data of three years mentioned below-

#### **Waste Management**

In semi-urban cities, waste management becomes a particularly challenging problem due to limited infrastructure, rapid population growth, and inadequate resources. These areas often lack the necessary systems for efficient waste collection, sorting, and disposal, leading to the accumulation of garbage in public spaces and open dumpsites. People in semi-urban areas may not have access to



reliable recycling facilities, which results in large quantities of recyclable materials being wasted. Moreover, with limited awareness about the importance of proper waste disposal, improper practices like burning trash or littering are common, further exacerbating pollution and health risks. The lack of funds and technical expertise to manage waste effectively in these regions makes it crucial to develop sustainable solutions that balance the needs of growing populations with environmental

preservation. Between 2020 and 2021, Antakshari Foundation initiated a comprehensive waste management project across five villages in the Kakalwara Gram Panchayat in the Arain block of Ajmer, Rajasthan. The program was launched to improve cleanliness, promote sustainable waste management practices, and enhance environmental awareness among the local communities. The project focused on the systematic collection and segregation of waste, wherein the team gathered both wet and dry garbage directly from the households in the villages. The wet waste was then carefully processed and converted into organic compost, which was later distributed to local farmers to enhance soil fertility and support sustainable agricultural practices. On the other hand, dry waste, including plastic, metal, and paper products, was segregated and sent for recycling, ensuring minimal environmental impact. This holistic approach to waste management not only reduced the burden on landfills but also contributed to the reduction of pollution and the promotion of a circular economy. The project was officially inaugurated by Suresh Chand Tank, the then Member of Legislative Assembly (MLA), who expressed his support for the initiative, acknowledging its potential to improve the quality of life in the villages and raise awareness about the importance of waste segregation. Throughout the course of the project, the team worked closely with local communities, educating them about the benefits of proper waste disposal and involving them in the process, thereby fostering a sense of responsibility and ownership. This waste management initiative not only improved the cleanliness of the villages but also set a model for sustainable waste management practices in rural areas.



### Educational Campaign for Adolescent Girls in Dalit, Adivasi, and Backward Classes in Ajmer District

December 2021, In an important educational successfully campaign was conducted for adolescent girls from Dalit, Adivasi, and other backward classes across 40 villages in the Arain and Sri Nagar blocks of Ajmer district. The campaign aimed at addressing the multifaceted challenges faced by adolescent girls in accessing and continuing their education.



These challenges, including social barriers, financial constraints, and lack of institutional support, were particularly prevalent in rural communities, where the education of girls is often deprioritized. The educational campaign for adolescent girls in the Dalit, Adivasi, and backward communities of Ajmer district was a resounding success. It not only raised awareness about the importance of girls' education but also led to concrete actions in support of educational reforms. The campaign emphasized that education is a fundamental right for every girl, regardless of her socio-economic background, and paved the way for a future where girls in these communities are more likely to stay in school, complete their education, and break free from the limitations imposed on them by society. As more girls join the educational journey, the hope is that this campaign will serve as a model for other regions facing similar challenges, ensuring that every girl has the opportunity to reach her full potential.

#### **Educational Barriers for Adolescent Girls**

Adolescent girls, especially those from marginalized communities, face multiple obstacles in pursuing education. It was classified in three category -

- **Social Barriers**: Cultural norms and societal expectations often limit girls' freedom to pursue education. In many rural settings, girls are expected to fulfill domestic roles at home, leading to a discontinuation of their schooling.
- **Financial Constraints**: Families from Dalit, Adivasi, and backward classes often face economic hardships, which prevent them from affording education-related expenses such as school fees, transportation, and materials.
- Lack of Infrastructure and Support: Limited access to schools, especially in remote villages, and the absence of basic amenities like toilets for girls often discourage them from continuing their education.



Through the campaign, the voices of these adolescent girls were amplified, bringing attention to the critical need for support and reforms in the education system.

### **Campaign Objectives and Activities**

The educational campaign aimed at:

- **Raising Awareness**: The campaign educated the community about the importance of education for girls and the long-term benefits it brings not only to individuals but also to families and society at large.
- **Mobilizing Local Support**: The campaign involved local stakeholders, including parents, teachers, community leaders, and elected representatives, in order to create a supportive environment for girls' education.
- **Collecting the Demands of the Girls**: Kishori (adolescent girls) from various villages were encouraged to share their experiences, challenges, and demands regarding their educational journey.

### Key Demands Submitted to the Sarpanch

On December 17, 2021, a memorandum highlighting three key demands was submitted to the

Sarpanch of Kalkalwara Gram Panchayat in Ajmer district, which was central to the campaign. These demands were:

Free and Compulsory Education for All Girls from 9th to 12th Grade: Recognizing that many girls were unable to continue their education beyond the primary level due to financial and social constraints, the demand called for free and compulsory education for



girls up to the 12th grade, ensuring that every girl has the right to complete her schooling.

- 1. Scholarships for Every Girl to Complete Her School Education: Financial difficulties were one of the primary reasons why girls dropped out of school. The demand for scholarships aimed at providing financial support to ensure that no girl is forced to leave school because of a lack of resources. The scholarship would cover tuition fees, books, uniforms, and transportation.
- 2. A Direct Cash Scholarship of 5000 Rupees for Every Girl: This demand sought a direct financial incentive for girls to remain in school. The cash scholarship would serve as both financial support and a recognition of the importance of girls' education, thereby motivating more families to prioritize the education of their daughters.

### Impact of the Campaign

The campaign had a profound and transformative impact on the girls in these communities:

• **Empowerment and Awareness**: By participating in the campaign, many Kishori girls became more aware of their rights to education. They started questioning the societal



norms that limited their opportunities and began demanding their right to continue their studies.

- **Social Change**: The campaign helped shift the local mindset about girls' education. Community leaders, parents, and educators were made aware of the importance of keeping girls in school, and more families began to support their daughters' education.
- **Increased Enrollment and Retention**: As a direct result of the campaign and the demands raised, several girls who had previously dropped out of school or had been hesitant to attend resumed their education. The promise of scholarships, both in terms of financial aid and direct monetary support, encouraged many families to send their daughters to school.
- Local Government Support: The submission of the memorandum to the local Sarpanch brought institutional attention to the issue. Although immediate changes were not made, the memorandum set the stage for ongoing dialogue between the community and local government authorities, with the promise of future educational reforms in the region.

### Project Pragati 2023-2024

The Antakshari Foundation, in collaboration with Educate Girls, successfully launched Project Pragati between 2023 and 2024, aiming to empower and support girls in their educational journey. The project focused on enrolling 1,295 girls age between 14 to 29 in Class 10th, ensuring they received the necessary resources to excel in their academic endeavors. As part of the initiative, educational camps were established in the girls' respective villages, creating a local and accessible environment for them to engage in quality learning. These camps were designed to bridge the educational gaps and provide personalized guidance, helping the girls prepare for their Class 10th exams. Through this initiative, Project Pragati aimed to improve academic performance and foster confidence and skills among these girls, enabling them to pursue further education and future opportunities. The initiative demonstrated a significant step toward ensuring that girls in rural areas have equal access to education, equipping them with the tools needed for a successful academic and professional future. 1310 girls successfully enrolled in the 10th class examination through RSOS under Project Pragati. Out of the total enrolled students, 1236 girls were issued admit cards, enabling them to sit for the examination. Out of the 1236 girls who received their admit cards, 873 girls appeared for the examination. This shows a substantial participation rate, indicating the commitment of the enrolled students toward completing their education. However, it is important to note that 215 girls, while receiving admit cards, only appeared partially for the exam, which indicates that they could not appear for the entire exam or may have faced other barriers preventing full participation. Upon the declaration of results, 375 girls passed the 10th class examination, reflecting the success and hard work of the students and the foundation's efforts in providing support. These students are now poised to continue their academic journey or seek further opportunities in various vocational or professional fields.

Another 560 girls faced the Subject Yet to be Clear (SYC) exams in one to three subjects. This indicates that while they were not able to pass all subjects in the first attempt, they now have



the opportunity to reappear for the subjects they were unable to clear, with hopes of passing and obtaining their 10th class certification in the next cycle.

### Conclusion

Project Pragati has been a significant step toward promoting education among young girls, especially those who might otherwise have faced barriers to accessing formal education. While a substantial number of girls passed their exams, the foundation continues to support those who are facing challenges, whether through supplementary exams or resolving any registration discrepancies. The success of this initiative reflects the dedication of both the students and the Antakshari Foundation, and it is hoped that future cohorts of Project Pragati will continue to thrive and benefit from similar opportunities.

### Antakshari Internship Programmes

Internship at ANTAKSHARI provides a unique opportunity for students interested in gaining practical hands-on experience on the broader relationship between theoretical and practical aspects and explores the classroom learning with the field and policy level experiences in the State. The broad range of internship opportunities at Antakshari allows prospective interns to opt for the topics based on their areas to gain their professional experience.

The areas where they are exploring their expertise like Child Rights, Policy level initiatives in Child Protection, Assessment of Acts in the field level, Capacity assessment of various stakeholders working in Child Protection. Antakshari Foundation offers 10 weeks of Internship program but it can tailor it for greater or lesser period of time. The Organization also has formal tie-ups with various Institutes and Universities across the State.

We are committed to supporting children to be safer and secure environment and a committed and confident to recognize, prevent and seek help for all forms of violence against them, and to make the child protection mechanisms more strengthen and vibrant for children in vulnerabilities.

In continuation to it Antakshari Foundation has various policies and programmes level contributions in the field of child protection, viz:-

- Recognized as a technical partner of Department for Child Rights (DCR) and Centre for Child Protection (CCP) in Sardar Patel University of Police (SPUP), Jaipur.
- Contribute its technical support in framing of Juvenile Justice (Care and Protection of Children) Rules of Rajasthan.
- Trainings and Capacity building of various Child Protection stakeholders.
- Development of academic course in Child Protection with Sardar Patel University of Police, Security and Criminal Justice, Jodhpur.
- Development of training calendar for authorities working under JJ system (CWC & JJB) and modules.
- Development of specialized cadre on Child Protection through formations of Resource Group on Child Protection.
- Development of Advocacy Group on Child Protection by developing advocacy strategy note on various gaps and challenges in the implementation of legislations &programmes.
